

Giving Privacy Policy

Campus Movement is committed to protecting the privacy and security of those who generously support our ministry. This Giving Privacy Policy explains how we collect, use, and protect information provided when you make a donation to Campus Movement through our website or online giving platform.

Information We Collect

When you make a donation to Campus Movement, we may collect personal information such as:

- Your name
- Email address
- Mailing address
- Phone number
- Donation amount
- Donation frequency
- The ministry, staff member, event, or fund you choose to support
- Information necessary to process and document your donation

Payment information submitted through our online giving platform is processed through Planning Center Giving and its payment processing services. Campus Movement does not use donor payment information for purposes unrelated to processing and documenting your donation.

How We Use Your Information

We use donor information to:

- Process your donation
- Provide donation receipts and giving statements
- Maintain accurate financial and donor records
- Communicate with you regarding your donation
- Provide ministry updates and other communications you have chosen to receive
- Respond to questions or requests
- Comply with applicable legal, accounting, and tax requirements
- Improve our giving process and donor experience

Donor Privacy

Campus Movement respects the privacy of our donors. **We do not sell, rent, or trade donor personal information to outside organizations for their marketing purposes.**

Donor information may be accessible to authorized Campus Movement personnel and trusted service providers when necessary to process donations, maintain financial records, provide communication services, or perform other functions on behalf of the ministry.

Access to donation information within Campus Movement is limited to individuals who have a legitimate ministry or administrative need for that information.

Online Giving and Planning Center

Campus Movement uses **Planning Center Giving** to facilitate online donations. Information submitted through our online giving process may be collected and processed by Planning Center and its payment-processing partners.

Planning Center maintains security measures designed to protect donor and financial information, including controlled access to Giving data and payment-security practices. Planning Center states that its payment processing is PCI compliant and that access to Giving information is restricted through permission levels.

Communications

If you provide your email address or other contact information, Campus Movement may use that information to send donation receipts, giving statements, ministry updates, newsletters, or other communications.

You may unsubscribe from non-essential ministry communications at any time by using the unsubscribe option included in those communications or by contacting Campus Movement.

We may continue to send transactional communications that are necessary to process or document your donation, such as donation receipts and giving statements.

Information Required by Law

Campus Movement may disclose personal information when we believe in good faith that disclosure is necessary to:

- Comply with applicable laws, regulations, or legal processes
- Respond to a valid governmental or legal request
- Protect the rights, property, or safety of Campus Movement, our donors, or others
- Prevent or investigate fraud or other unlawful activity

Data Security

Campus Movement takes reasonable measures to protect donor information from unauthorized access, disclosure, alteration, or destruction.

Because no method of transmitting or storing information electronically can be guaranteed to be completely secure, we cannot guarantee absolute security of information transmitted through our website or online giving platform.

Third-Party Services

Our website and giving process may contain links to or use services provided by third parties. These third parties may have their own privacy policies and terms governing their collection and use of information.

Campus Movement is not responsible for the privacy practices of third-party websites or services that we do not control.

Changes to This Policy
